II. Qualifier Tournament Assignments Announced: January 27, 2025

Planned: Like Track & Field, Member Organizations will be assigned to one of two Qualifying Tournaments*

A. Lafayette Qualifier Tournament: March 1, 2025,
Oakbourne Country Club, Lafayette

B. Lake Charles Qualifier Tournament: March 8, 2025,
Ward 3 Recreation Tennis Complex, Lake Charles

C. How Tournament Locations are Chosen: Based on Member location (as much as possible) and total number of student-athletes rostered at Commitment and Fee Deadline of January 13, 2025, Qualifier locations will be chosen and announced by on or before January 27, 2025.

Goal: to have two evenly-matched qualifying tournaments with the best tennis players from each advancing to the State Championship Tournament.

Expected: Qualifying Tournaments in Lafayette and Lake Charles

** As usual, depending on the volume of Commitments and rostered student-athletes, this assignment of Qualifying Tournaments may change and will be communicated after the January 13 Commitment/Roster/Fee Deadline.*

III. Final Roster Deadline: February 14, 2025

Submitted only if there are any changes from the January 13, 2025 Official Roster; only for changes to existing Official Roster. Examples:

1. A JV-eligible Boy moving from JV to Varsity competition
2. Two Varsity Girls Singles players moving to a Doubles team (as long as the requirement of up to four entries is maintained)

B. Lake Charles Qualifier Tournament: March 8, 2025, Ward 3 Recreation Tennis Complex, Lake Charles

C. Seeding Style: no different from last year, USTA data (if available) will be used to help seed for Qualifiers only

D. Qualifying for the State Tournament: a student-athlete or doubles team must win at least one match in Qualifier-either first round or consolation to advance

E. Rain Plan: Alternate Qualifier Date is March 15, 2025
